4.1 Run, Hide, Fight Training

M. McGinty (45 min)

- Earlier this year, began soft roll-out of "active threat/run hide fight" training to groups of staff, especially emergency wardens
- In September, at start of new term, host some in-person workshops and provide online training via video and slides
- Please suggest any key audiences that should see presentation in face-to-face format
- RMS would like to provide presentation to faculty audience: faculty are not more responsible for student safety during active threat incident than anyone else on campus, but are in position where students may look to them

- Definition of "active shooter:" actively shooting at other people; multiple targets in confined, populated spaces
 - o Indiscriminately threatening violence, does not follow apparent pattern or method; potential threat to everyone
 - o "Active threat" extends definition to other weapons/threats
- Training gives people tools to make informed decisions during active threat situation,
- Treats people's perception of risk as much as the real risk; reiterates that UBCO campus is a very safe place to be

Addendum 1 Risk Management Services Incident Report Summary – March 2017 University of British Columbia (Okanagan Campus) Health and Safety Committee April 24th, 2017

- 1. Staff Accident/Incident Reports Injury Reported March 1st 31st, 2017:
 - March 31st: A worker felt muscle strain in their left forearm while loading a stock cart onto the back of a pick-up truck with another staff member. The stock cart was an awkward item to load and thus it slipped while being loaded onto the back of the truck. The stock cart was also heavy making it a challenge to lift. The supervisor's corrective actions are for workers to request additional support in moving items of this nature in the future, and potentially request use of the Facilities Mgmt. cube van that has a ramp. RMS also recommends considering, if practicable, breaking the load into smaller units or removing items from the cart for the loading/transfer/unloading processes.

Cause unknown as condition of stairs was satisfactory and safe. Presumed that he missed step and/or lost balance. Transported to Health & Wellness. On 20 MAR 2017 at 1550H Aramark staff attended Dispatch and requested Security First Aid wrap a burn injury that she had sustained on her left hand. The injury occurred on 16 MAR 2017 and was attended at that time by Security. March 16 2017 1703 hours Aramark staff requested treatment for a burn she suffered to her left forearm, wrist and thumb when she accidental poured hot liquid on herself by mistake. Work Safe Paper work and initial patient assessment form completed. Advised to seek additional medical care and to not go back to work. Staff proceeded to clinic for further assessment.
