### Addendum 1

Risk Management Services Incident Report Summary: February 26/18 - March 25/18 University of British Columbia (Okanagan Campus) Health and Safety Committee March 26, 2018

### 2. <u>Staff Accident/Incident Reports</u> - Injury Reported - Feb. 26 - Mar. 25:

- Feb 26<sup>th</sup>: A worker had entered a building to access her office when she slipped and fell in the hallway suffering various minor impact injuries. Campus Security provided first aid treatment. The worker had been wearing snow grips outside; she did not remove them when she entered the building. The grips are constructed of rubber with wrapped metal wire on the bottom for traction in snowy and icy conditions; instead of providing traction on the linoleum-style floor, the metal wrapping created a slipping hazard. A WorkSafeBC claim was not submitted.
- Mar 15<sup>th</sup>: A worker was doing project work at an off-campus location when she tripped on a small transition in the floor, falling and fracturing her arm. The transition is not normally exposed (i.e. is hidden under a folding door) but it was exposed for this event as the folding door was open to allow for moving larger items from one area to another. A WorkSafeBC claim for health care and lost time is in progress.
- Mar 22<sup>nd</sup>: A worker was teaching a class in a smaller classroom. She turned to take a step to adjust a component of the A/V setup when she tripped on the A/V and power cables going from the wall to the table that her laptop and hard drive were sitting on. She fell on her knees causing impact injuries (bruising, swelling). The force of her legs hitting the cables caused the laptop and hard drive to fall off of the desk, damaging both items. Campus Security provided first aid treatment. At the time of writing, no WorkSafeBC claim had been filed.
