- 4.1 Centralised funding for committee-related training

- No current process or centralized budget for UHSC training (optional 8 hours annual leave allowed by employment agreements/legislation)

 - Committee members should have opportunity to take advantage of annual leave entitlement for training without having to fund committee training themselves or through PD funds (i.e. ensure lack of funding is not a barrier to accessing training)
 - All committee members should have equal access to funding for training irrespective of employment group or which committee they sit on (following the roll-out of new committee structure)

 - Bollards and chain with padlock now in place to prevent/reduce instances, approved by Kelowna Fire Department
 - Jaywalking at Alumni Avenue
 - Signage and barricades now in place
 - Meeting was held with City of Kelowna to discuss concerns
 - City may alter trail to add access path for Fortis and rail trail path, decommission existing pathway
 - John Hindle pedestrian overpass now open

 - City may add either sidewalk, or signage denoting it as shared-use path as there is relatively little traffic in that area
 - Line painting would be done next year; in the interim, signage and bollards will be put in place

Addendum 1

Risk Management Services Incident Report Summary: Sept. 24 - Oct. 21, 2018 University of British Columbia (Okanagan Campus) Health and Safety Committee October 22, 2018

Staff Accident/Incident Reports - Injury Reported - Sept. 24 - Oct. 21:

No reports for this time period.

Staff Accident/Incident Reports - No Injury Reported - Sept. 24 - Oct. 21:

Oct. 4th: Two graduate students were performing high-temperature processing (i.e. sintering) of thoria powder (which is radioactive). The thoria was placed inside a die and sealed with a double-layer of which was then placed inside the chamber. During the sintering process, the die cracked, spilling a small quantity of the powder within the sealed chamber. Nothing leaked outside of the chamber. The lab was locked down and specialized processes were implemented to clean the thoria from the chamber. Post-cleaning wipe tests were performed to ensure that the thoria was fully removed from the chamber. One issue that emerged from this process was an inability to modify the Salto access for the cleaning period. Doors were signed "no access" and Campus Security is following up on Salto procedures.

Oct. 18th: Workers in the High Head Engineering Lab heard a loud noise and then noted significant cracking in one of the walls. Facilities Mgmt was contacted and a structural engineer was brought onto campus to assess the situation. It was determined that the wall is not a load-bearing wall and the cracks are simply cracks in the drywall, likely caused by settling over time. A subsequent concern was identified regarding a crack in the concrete floor of the same lab that the workers felt had expanded over the previous 24 hours. The structural engineer was brought back onto campus; it was noted that the crack stretched between two floor penetrations. At one of the penetrations, a "massive" foundation was added after original construction; during this process, it is possible that some of the material below the foundation sloughed somewhat. This combined with normal slab shrinkages across the floor have likely led to the large crack at this particular location. The engineer did not feel that this floor crack indicates any type of safety issue.
