- Throughout semester informational booths

 - More containers
 - Education and reduction of stigma
 - Applying for SUO funding
 - o BC Transit containers outside near bus loop
 - o Individual sharps containers available from nurse
- Questions

Addendum 1

Risk Management Services Incident Report Summary: Oct. 22 - Nov. 25, 2018 University of British Columbia (Okanagan Campus) Health and Safety Committee November 26, 2018

2. Staff Accident/Incident Reports - Injury Reported - Oct. 22 - Nov. 25:

Oct. 25th: Two lab workers were standing in front of the lab's fermenting devices when a large waft of sewer gas hit them. They both experienced headaches instantly and evacuated the area. Previous reports of CO and H₂S levels associated with these odors have occurred.

Oct. 25th: A practicum student went to deliver an injection to a patient with little adipose (i.e. fatty) tissue. The student had proper psychomotor skills, but the patient had very little adipose tissue and the student poked through the patient's skin and then poked herself.

<u>Nov. 2nd</u>: A computer fell on a worker's foot. At the worker's height-adjustable (i.e. sit-stand) desk, the power bar for the computer was not attached and thus it "floated" as the desk was raised or lowered. Right before the incident occurred, the worker was lowering the desk. During this process, the power bar became pinned underneath the tower and the floor. With the desk in the downward motion the tower was lifted and the pins holding in place were disengaged. This caused the computer tower to come free and fall on the worker. A corrective action for this could be to ensure all power bars are secured to the desk, with enough cable available to not impede the operation of the desk.

Nov. 5th: A worker was servicing a light fixture in the ceiling above him when a piece of dust fell into his eye. Campus Security provided First Aid services by flushing the worker's eye with saline solution.

Nov. 5th: A worker was manually pushing a skid of light-weight materials when he felt a 'tweak' in his neck. Campus Security provided initial first aid, the worker then sought additional medical treatment.

<u>Nov. 9th</u>: A worker was attempting to open an exit door (worker indicated that this door had been 'sticky' in the past). She couldn't open it on the first try so tried again with increased force. The impact of the second attempt caused injuries to her shoulder. The worker submitted a work request to Facilities Mgmt to have the door serviced so it will open properly.

Nov. 15th: A worker was in the process of standing up at her desk. The computer cables that were hanging under the desk wrapped around her lower leg as she went to stand, and she tripped jarring her lower back. The computer cabling had become disconnected from the wall; they have since been re-affixed.

Nov. 15th: (student incident) - shortly before 5:00pm, a vehicle was exiting 'J' Lot turning left onto Alumni Ave towards Hindle Drive when it struck a pedestrian that was crossing the crosswalk from west to east. The pedestrian did not activate the flashing crossing lights. The driver could not see pedestrian in part because pedestrian was hidden behind the relatively thick 'A' pillar of the pick-up truck being driven. Multiple people commented that when Nonis Field lighting came on approx. 5 minutes later, the intersection was much more brightly lit. That being said, there is a street light immediately south of the crosswalk.

1. Staff Accident/Incident Reports - No Injury Reported - Oct. 22 - Nov. 25:

Nov. 2nd: At approximately 4:30pm on Friday Nov. 2, a worker discovered that a manufactured filter hose had failed. The worker isolated the leak and refilled the hydronic system. The department manager reviewed the incident Monday morning with the campus Charge Engineer and HVAC tech. This group developed recommendations to check all other filter hoses on campus; they also discussed if these filter hoses should be hard piped.

Nov. 8th: A variety of abandoned materials were discovered 'hidden' beside a dumpster on the south side of the EME Building; this was then reported to Risk Management Services. Through subsequent investigation, the 'owners' of the materials have been identified. RMS is working with the responsible parties to ensure that proper procedures are used in the future.

<u>Nov. 20th</u>: An inexperienced driver was reversing a cube truck when the truck box very slightly grazed the edge of a roof overhang; damage was minor/superficial.

Nov. 22nd: Lab technicians were servicing a piece of equipment when a spill of hydraulic oil occurred; the department's safety lead was contacted, he ensured that the spill was cleaned up immediately to mitigate the slipping hazard.

First-aid performed a brief mobility assessment and advised staff seek follow up care, to which staff stated he had already contacted medical professional for further assessment. Modified duties was recommended. On November 5, 2018 at approximately 1251 hours Facilities Staff walked in to the campus security office with a foreign object in his left eye. He stated he was doing overhead work when something entered his eye around 1000H on the same day. He stated he was wearing eye protection. Visitor to campus had fallen when disembarking a bus. He had a minor laceration above his right eye, and no other reported or observed injuries or symptoms. Initially the visitor denied medical attention, stating he was on new medication and still adapting to it. Wound was dressed, by first-aid attendant upon request (was not going to be provided transport unless dressed). Believed that fall was not the result of either UBC or bus conditions. 30 requests for first-aid outside the scope of the UHSC (sports injury, mental health, illness, drug/alcohol overconsumption)

3 REPORTS	 On November 15, 2018 at 1645 hours pedestrian (a student) was struck by vehicle while in pedestrian crosswalk on Alumni Avenue/J lot. Driver inattention/fault, lighting, and pedestrian failure to activate crossing lights may all be a factor. Estimated that driver was driving at or less than speed limit. Incident currently under review. Pedestrian was transported to hospital. On November 13, 2018 at approximately 1013 hours person reported that their vehicle had struck by a male on skateboard in H lot. She stated she was crossing the raised pedestrian crosswalk when another student, struck the rear driver side quarter of her vehicle. Pedestrian stated that he verbally declined being injured that he was able to walk away from the incident under his own power. She also denied noticing any damage to her vehicle. Both parties exchanged contact information at the scene. On November 1, 2018 at 1057 hours: Staff member reported that his service vehicle was reversed into by another vehicle in M Lot. No injuries. Minor damage to both vehicles. Security attended to document and assess.
